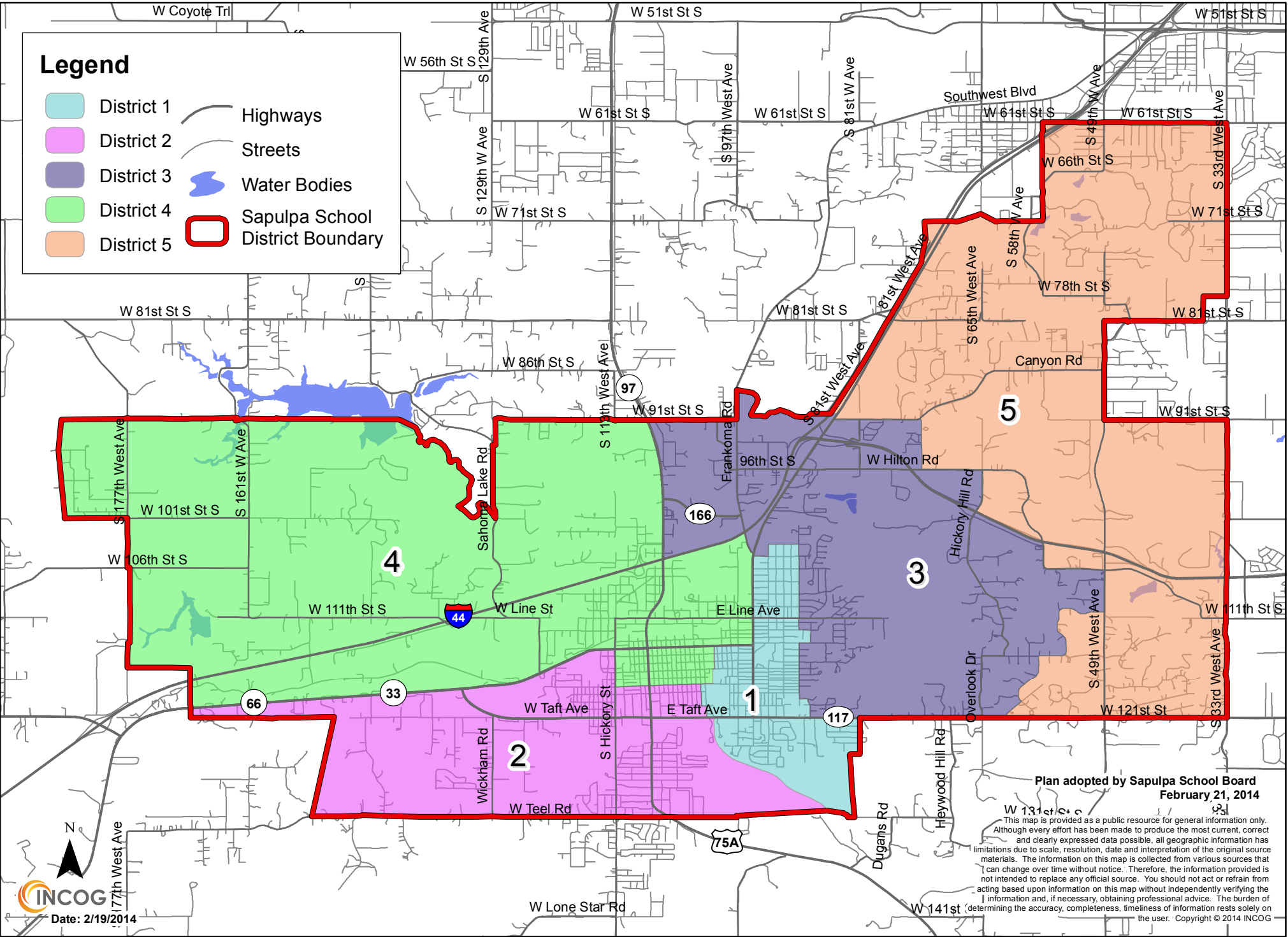


# Sapulpa School Board Districts - Adopted Plan 2014

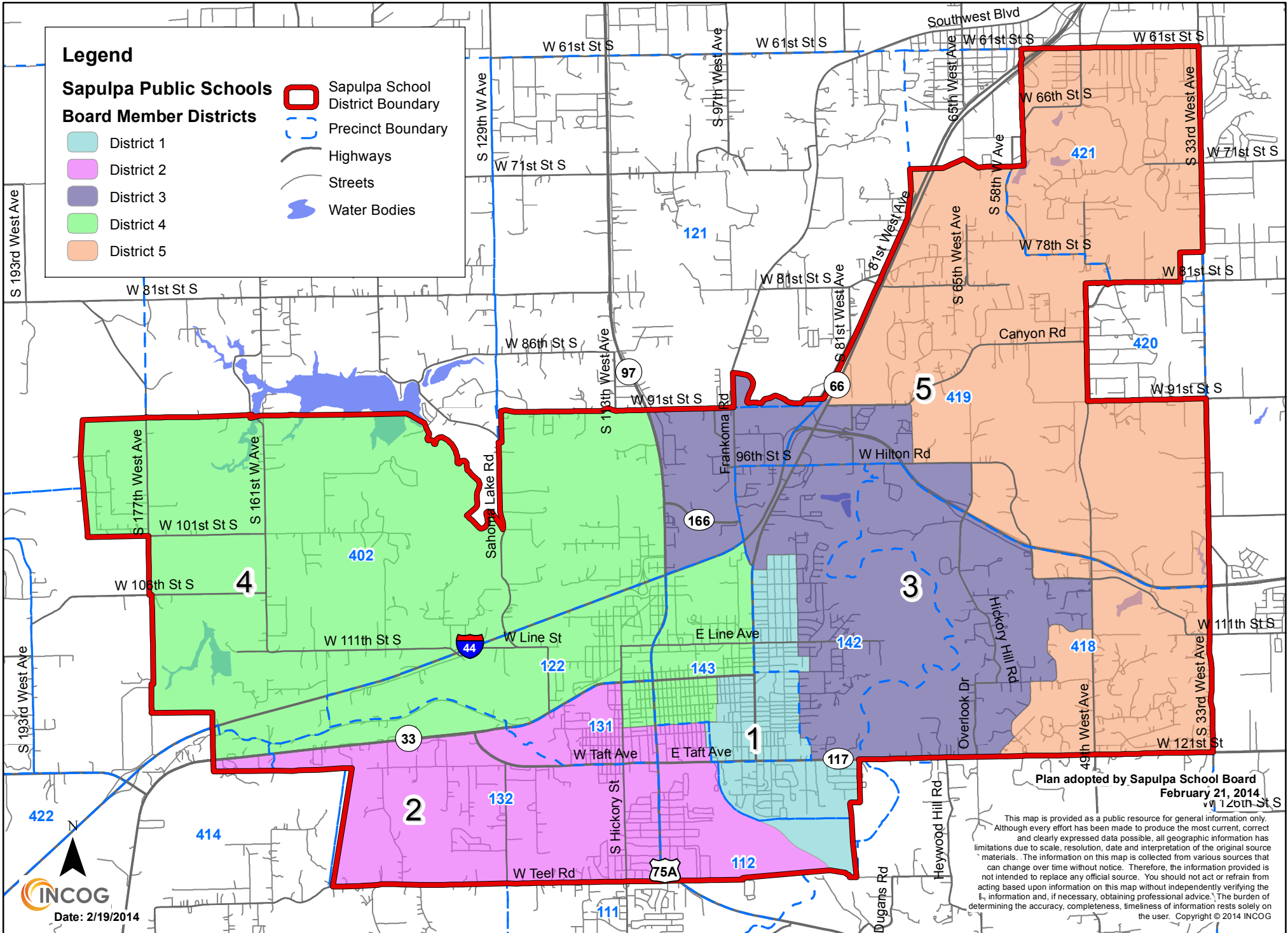

Beginning at the centerlines of the intersection of North Mission Street/State Highway 66 and East James Avenue, thence east along the centerline of East James Avenue to the centerline of North Ridgeway Street, thence north along the centerline of North Ridgeway Street to the centerline of East Hill Avenue, thence east along the centerline of East Hill Avenue to centerline of North Brown Street, thence south along the centerline of North Brown Street to the centerline of East Line Avenue, thence west along the centerline of East Line Avenue to the centerline of North Boyd Street, thence south along the centerline of North Boyd Street to the centerline of East McLeod Avenue, thence east along the centerline of East McLeod Avenue to the centerline of North Moccasin Place, thence south along the centerline of North Moccasin Place to the centerline of East Dewey Avenue, thence west along the centerline of East Dewey Avenue to the centerline of South Boyd Street, thence south along the centerline of South Boyd Street to the centerline of Edgewood Lane, thence east along the centerline of Edgewood Lane to the centerline of South Boyd Place, thence southeast along the centerline of South Boyd Place to the centerline of East Grayson Avenue, thence east along the centerline of East Grayson Avenue to the centerline of South Boyd Place, thence south along the centerline of South Boyd Place to the centerline of East Taft Avenue/State Highway 117, thence east along the centerline of East Taft Avenue/State Highway 117 to Brenner Road, thence south along the centerline of Brenner Road and the Sapulpa Public School District boundary approximately 1,903 feet, thence west continuing along the Sapulpa Public School District boundary approximately 461 feet, thence south still following the Sapulpa Public School District boundary approximately 3,347 feet to the centerline of West 131<sup>st</sup> Street South, thence west along the centerline of West 131<sup>st</sup> Street South and the Sapulpa Public School District boundary approximately 297 feet, thence north and northwest along the Sapulpa Public School District boundary approximately 1,012 feet to the centerline of the Tulsa/Sapulpa Union Railway, thence northwest and north along the centerline of the Tulsa/Sapulpa Union Railway to the centerline of East Taft Avenue/State Highway 117, thence west along the centerline of East Taft Avenue/State Highway 117 to the centerline of South Maple Street, thence north along the centerline of South Maple Street to the centerline of East Washington Avenue, thence west along the centerline of East Washington Avenue to the centerline of the ally running north and south between South Maple Street and South Walnut Street, thence north along said ally to the centerline of East Bryan Avenue, thence east along the centerline of East Bryan Avenue to the centerline of the Tulsa/Sapulpa Union Railway, thence north along the centerline of the Tulsa/Sapulpa Union Railway to the centerline of East Lincoln Avenue, thence east along the centerline of East Lincoln Avenue approximately 67 feet to the centerline of unnamed road/ally 167 feet west of South Spruce Street, thence north along the centerline of unnamed road/ally to the centerline of East Dewey Avenue/State Highway 66, thence east along East Dewey Avenue/State Highway 66 to the centerline of North Mission Street/State Highway 66, thence north along the centerline of North Mission Street/State Highway 66 to the centerline of East James Avenue said point also being the point of beginning.

Beginning at the centerlines of the intersection of West Dewey Avenue/State Highway 66 and South Hickory Street, thence south along the centerline of South Hickory Street to the centerline of West Bryan Avenue, thence east along the centerline of West Bryan Avenue approximately 3,680 feet to the centerline of the unnamed road/ally between South Walnut Street and South Maple Street, thence south along the centerline of the unnamed road/ally approximately 1,159 feet to the centerline of East Washington Avenue, thence east along the centerline of East Washington Avenue to the centerline of South Maple Street, thence south along the centerline of South Maple Street to the centerline of East Taft Avenue/State Highway 117, thence east along the centerline of East Taft Avenue/State Highway 117 to the centerline of the Tulsa/Sapulpa Union Railway, thence south and southeast approximately 7,487 feet along the centerline of the Tulsa/Sapulpa Union Railway to the Sapulpa Public School District boundary, thence west along the Sapulpa Public School District boundary approximately 3,938 feet, thence south continuing along the Sapulpa Public School District boundary approximately 80 feet to the centerline of East Teel Road, thence west along the centerline of East Teel Road, West Teel Road and the Sapulpa Public School District boundary approximately 3.5 miles to a point, thence north continuing to follow the Sapulpa Public School District boundary approximately 5,392 feet, thence west along the Sapulpa Public School District boundary approximately 6,231 feet, thence north along the Sapulpa Public School District boundary approximately 527 feet to the centerline of State Highway 66, thence northeast along the centerline of State Highway 66/West Dewey Avenue to the centerline of South Hickory Street said point being the point of beginning.

Beginning at the centerlines of the intersection of West 91<sup>st</sup> Street South and the northbound lanes of State Highway 97, thence southeast and south along the centerline of the northbound lanes of State Highway 97 and then the centerline of State Highway 97/North 9<sup>th</sup> Street to the centerline of Interstate 44/Turner Turnpike, thence northeast along the centerline of Interstate 44/Turner Turnpike to the centerline of Frankoma Road/97<sup>th</sup> West Avenue, thence southeast along the centerline of Frankoma Road/97<sup>th</sup> West Avenue to the centerline of State Highway 66/New Sapulpa Road, thence south along the centerline State Highway 66/New Sapulpa Road to the centerline of East Dewey Avenue, thence west along the centerline of East Dewey Avenue to the centerline of South Spruce Street, thence continue west along East Dewey Avenue approximately 135 feet to the centerline of unnamed street approximately 100 feet east of the Tulsa/Sapulpa Union Railway, thence south along the centerline of unnamed street to the centerline of East Lincoln Avenue, thence west along the centerline of East Lincoln Avenue to the centerline of the Tulsa/Sapulpa Union Railway, thence south along the centerline of the Tulsa/Sapulpa Union Railway to the centerline of East Bryan Avenue, thence west along the centerline of East Bryan Avenue to the centerline of South Hickory Street, thence north along the centerline of South Hickory Street to the centerline of West Dewey Avenue/State Highway 66 and State Highway 33, thence west and southwest along the centerline of West Dewey Avenue/State Highway 66 and State Highway 33 approximately 3.6 miles to Sapulpa Public School District boundary, thence north continuing along the Sapulpa Public School District boundary approximately 2,132 feet, thence west approximately 2,719 feet along the school district boundary, thence north approximately 1,306 feet still following the school district boundary, thence east approximately 95 feet along the school district boundary, thence north approximately 4,001 feet to the centerline of West 106<sup>th</sup> Street South and the Sapulpa Public School District boundary, thence west along the centerline of West 106<sup>th</sup> Street South to the centerline of South 177<sup>th</sup> West Avenue, thence north along the centerline of South 177<sup>th</sup> West Avenue to the centerline of West 101<sup>st</sup> Street South/Sapulpa Public School District boundary, thence west from the centerline of West 101<sup>st</sup> Street South/Sapulpa Public School District boundary approximately 2,730 feet along said school district boundary, thence north approximately 5,275 feet continuing along the Sapulpa Public School District boundary, thence east approximately 2,855 feet to the centerlines of the intersection of South 177<sup>th</sup> West Avenue and West 91<sup>st</sup> Street South, thence continuing east along the centerline of West 91<sup>st</sup> Street South to the centerline of South 161<sup>st</sup> West Avenue/Sapulpa Public School District boundary, thence continuing to follow the school district boundary south and east to the intersection of the centerlines of D0384 Road and West 91<sup>st</sup> Street South, thence east along the centerline of West 91<sup>st</sup> Street South and the Sapulpa Public School District boundary approximately 1,203 feet to the end of West 91<sup>st</sup> Street South, thence continuing east and southeast following the Sapulpa Public School District boundary approximately 3 miles to the centerline of Sahoma Lake Road, thence north along the centerline of Sahoma Lake Road and the school district boundary approximately 3,717 feet, thence east still on the school district boundary approximately 141 feet, thence north continuing along the school district boundary approximately 1,398 feet to the centerline of West 91<sup>st</sup> Street South, thence east along the centerline of West 91<sup>st</sup> Street South to the centerline of the northbound lanes of State Highway 97, said point being the point of beginning.
