<u>Pools Info</u>

1. A coaches' meeting will take place at 7:30 AM in the hospitality room of PEG North.

2. Pool matches will consist of 3 sets, no matter what happens in the first 2 sets. Sets will be to 25, cap of 30.

3. Warm-up for the 1st time a team plays will be 5-5-2. After each team has played once, warm-up for the remainder of the day will be 4-4-1.

4. Each reffing team will provide a scorekeeper, libero tracker, score flipper, and 2 line judges.

Tie Breaking Procedures

After the round robin pool play, teams will be ranked based on sets won. In the event of a tie, these steps will be used:

- 2 teams tied: 1) Head to head sets, 2) Head to head points, 3) Overall point differential, 4) 1 set to 25
 o For advancement, if still tied after head to head points, then play one set to 15.
- 3 teams tied: 1) Set % won between the 3 teams' sets played against each other, 2) Overall point differential, 3) Tiebreaker sets to 25. Coin flip will determine which team is off first and ref, while the other two teams will play one set to 15. The winner would play the team that was off, while the losing team would ref.
 - For advancement, top team is determined by set % won between the 3 teams' sets played against each other. Remaining two teams then play one set to 15.

Bracket Play

1. The top two teams in each pool will advance to the championship bracket to be played in the PEG South while the third-place team in each pool will advance to a consolation bracket in PEG North on court 3. 2. Since all teams are either playing or reffing during pool play, we will be taking a one-hour lunch break (11:00 AM – 12:00 PM) before beginning bracket play. Single elimination bracket matches will be best 2 of 3 to 25 with no cap, 3rd set to 15 no cap. Loser stays and refs. See the brackets for play order and reffing assignments. The winner of the championship bracket will be the conference tournament champion.

Other Reminders

1. Buses are to park at the JHS baseball parking lot north of the PE Gyms. The JHS baseball parking lot is located at 1010 North 3rd St. East, Jenks, OK 74037. Buses are not to park in the JHS bus oval or in the parking lot on the north side of the PE Gyms, as these parking spaces are for students and for parents. 2.
